**Section 21.**

It is an offence for someone who is prohibited by section 21 to have a firearm or ammunition in his possession at any time. Section 21 applies to anybody who has been sentenced to imprisonment or to youth custody or detention in a young offender's institution for three months or more. The period for which they are prohibited depends on the length of sentence – If the sentence was longer than three years, the prohibition lasts for five years from the date of their release. It is an offence for a person to transfer, let or hire, give or lend a firearm or ammunition to someone he knows or has reasonable grounds for believing to be prohibited by section 21.

It is a rule of the club, that subject to approval of the Committee. All candidates are required to serve a probationary period of up to six months before being considered for full membership if not a current FAC holder.

On completion, this form should be handed to the Hon. Secretary together with the appropriate fee. Upon acceptance as a full member a subscription for the remaining part of the year is payable, calculated proportionately for each month from the month acceptance as a probationary member. This amount will be calculated according to the current amount of the annual subscription. The annual subscription is decided at the AGM and is payable annually thereafter.
